

# INFORMATION FOR AUTHORS

**JOURNAL OF CULTURAL DIVERSITY (JCD)** for educators, researchers and practitioners involved in all areas of cultural diversity and the delivery of care, the development and implementation of programs, the formulation of policies, and the pursuit and analysis of research. *JCD* invites original articles on clinical practice, health issues, education, research, and social issues. All submissions must be accompanied by the following statement signed by the author(s):

“As the author(s) of (title of article), I/we hereby transfer copyright ownership to *JCD* if the work is published. I/we warrant that the article is original, has not been submitted to another journal, and has not been previously published.” Upon acceptance of the manuscript, the Copyright Transfer and Warranty Agreement below must be signed and returned to Tucker Publications, Inc.

## Refereed Publication

All manuscripts will be reviewed by the editor and at least two members of the review panel before a decision to publish is made. Accepted manuscripts may be revised in order to conform to the standards and style of *JCD*.

## Manuscript Submission

Manuscripts are accepted by e-mail only to [jcd@tuckerpub.com](mailto:jcd@tuckerpub.com)

Submitted papers **MUST** adhere to the following guidelines:

- MicroSoft Word documents only
- Typed double space with one inch margins
- Include a title page with
  - title of article
  - author(s) full name(s), academic degrees, affiliation, title(s)
- Identify each page with a number in upper right corner.

- The body of the manuscript should not exceed 14 pages (3500 words).
- List references on a separate page (try to limit to 25; use American Psychological Association (APA) style)
- Figures, charts and tables should be in black and white (no color)
- Type each figure, chart, table on a separate page
  - reference each one in the text
  - write a short legend for each one
- Include permissions for
  - all art work, as necessary
  - use of copyrighted material
  - include key words
- Include an abstract of 75-100 words
- Identify corresponding author, including home address and telephone number

If you wish the manuscript returned, include a stamped, self-addressed envelope. All correspondence concerning articles will be done in writing.

## Manuscript Editing

All manuscripts will be edited to conform to the style of *JCD*. The author is responsible for the content of the original and edited manuscript, once it is approved, and for the accuracy of references, quoted material, and for any violation of copyright.

## Illustrations, Charts, Tables

Photographs, line drawings, graphs, tables, and charts are encouraged if they enhance or amplify the text and are of publishable quality. All need to be referenced in the text. Photographs of people must be accompanied by a signed statement by the individual(s) photographed or the person with the legal right to sign such a statement.

## Letters to the Editor

Letters to the editor will be considered for publication. Address all correspondence to the editor.
